New Medicare Card Look-up Tool

Your Medicare Administrative Contractor's (MAC's) secure portal Medicare Beneficiary Identifier (MBI) look-up tool now returns the MBI even if the new Medicare card has not been mailed. If you do not already have access, sign up for your MAC's portal to use the tool. You can also ask your patients to call 1-800-MEDICARE to get a new card if they need one. To ensure your Medicare patients continue to get care, you can use either the Health Insurance Claim Number or the MBI for all Medicare transactions through December 31, 2019.
