MIPS: Error in 2019 Payment Adjustment

Recently, CMS discovered an error in the implementation of the 2019 Merit-based Incentive Payment System (MIPS) payment adjustment; it incorrectly applies payments for Medicare Part B drugs and other non-physician services billed by physicians. Adjustments to impacted claims will occur in the near future. If CMS overpaid a claim based on this error, you will get a notification for recoupment from your Medicare Administrative Contractor. DPH Announces Three Additional Flu Deaths

The number of laboratory-confirmed flu cases continues to increase in Delaware, and the Division of Public Health (DPH) is announcing three recent flu-related deaths, bringing the total number of deaths for the 2018-2019 season thus far to eight. There have been 1,268 laboratory confirmed cases of influenza in Delaware. This number reflects only the number of lab confirmed cases. The actual number of cases circulating statewide is likely to be much higher. Additionally, 224 people have been hospitalized with flu-like symptoms since the start of the flu season. These numbers are similar to the 2017-2018 season when at the same time, there were 1,289 laboratory confirmed cases of influenza. For more information visit: https://tinyurl.com/DELFLU2019.
