## MSD Takes Stand Against Recreational Marijuana

MSD, along with the Medical Societies in Connecticut, New York, and New Jersey, has signed a joint statement against the legalization of recreational marijuana. The group lists concerns regarding lack of scientific evidence that supports recreational marijuana use. The statement also supports reclassifying marijuana from a Schedule I to a Schedule II drug, which would enable government funding to be used for necessary research that clearly defines the positive and negative elements of marijuana use. ## Medical License Renewal Deadline

Medical licenses will expire on March 31 of odd-numbered years (2017, 2019, etc.). You must certify that you have completed the Mandatory Training in addition to the Continuing Medical Education (CME) required by the Rules and Regulations for your license. You may be selected for audit of your CME following the renewal. See "Renewing an Expired License" at <http://tinyurl.com/DEMEDLIC>. ## Beware of IRS Scams During Peak Tax Season

The Department of Justice Consumer Protection Unit is cautioning Delaware consumers and employers to be on guard for fake IRS phone call scams and IRS Form W-2 email phishing scams that are targeting Delaware employers, including retail businesses, school districts, nonprofit organizations, and law firms. The IRS says that these scammers often spoof the telephone number to disguise where they are calling from and manipulate the caller ID information. If you are worried that the call might be real, hang up and call the IRS directly at 1-800-829-1040.

## DPH Launches Lifesaving Smartphone App OpiRescue

As part of its multi-pronged approach to addressing the opioid crisis and reducing the number of individuals dying from drug overdoses in Delaware, the Division of Public Health (DPH) is announcing the launch of a new smartphone app that provides lifesaving step-by-step instructions on how to use naloxone during an opioid overdose. OpiRescue Delaware is a free, state-supported app available for download on all Android and Apple devices. The app contains detailed information on how to recognize signs of an overdose and includes animations on how to provide rescue breathing and administer naloxone, an overdose-reversing medication. Additionally, individuals can use the app to find the nearest available pharmacy carrying naloxone, which can be purchased without a prescription.
