## Nationwide Recall of Fentanyl Transdermal System

Alvogen, Inc. is voluntarily recalling two lots of Fentanyl Transdermal System 12 mcg/h transdermal patches to the consumer level. A small number of cartons labeled 12 mcg/h Fentanyl Transdermal System patches contained 50 mcg/h patches. The 50 mcg/h patches that were included in cartons labeled 12 mcg/h are individually labeled as 50 mcg/h. This transdermal system is manufactured by 3M Drug Delivery Systems, St. Paul, MN. Application of a 50 mcg/h patch instead of a prescribed 12 mcg/h patch could result in serious, life threatening, or fatal respiratory depression. # **Scam Alert: Taxpayers Warned of Fraudulent Letters**

The Delaware Division of Revenue wants to alert citizens to a new taxpayer scam that is happening in Delaware. Victims may receive a letter from "The Bureau of Tax Enforcement" that threatens property seizure and wage garnishment unless they call a toll-free number to "avoid enforcement." Taxpayers who may have received such a letter should contact the Division of Revenue at (302) 577-8200, option 3 and should also file a Consumer Complaint with the Delaware Department of Justice's Consumer Protection Unit.
