Call to Action - "No Surprise Act"

From the AMA and MSD: The House Energy and Commerce Subcommittee on Health is scheduled to "markup" H.R. 3630, the "No Surprises Act." While we support the patient protections included in this and other relevant bills, we cannot support the provisions that would resolve payment disputes between physicians and insurers by setting rates at the median in-network amount. Delaware's Congresswoman Lisa Blunt Rochester is on this committee. We urge you to call TODAY using the grassroots hotline at (800) 833-6354 and let Congress know that any surprise billing legislation should:

- Establish benchmark rates that are fair to all stakeholders in the private market; benchmark rates should include actual local charges as determined through an independent claims database.
- Establish a fair and independent dispute resolution (IDR) process to resolve disputes about payments from insurers to unaffiliated providers for services rendered out-of-network to their beneficiaries.
- Protect patients from out-of-network billing and preserve patient access to hospital based care by holding insurers accountable for addressing their own contributions to the problem.

2018 MIPS Performance Feedback and Final Score Now Available

If you submitted 2018 Merit-based Incentive Payment System (MIPS) data, you can now view your performance feedback and MIPS final score on the Quality Payment Program website. Access your 2018 MIPS performance feedback and final score by going to cms.gov/login. You must log in using your HCQIS access roles and profile HARP system credentials; these are the same credentials that allowed you to submit your 2018 MIPS data. The Delaware Medical Assistance Program (DMAP) continues to work toward solutions to resolve the challenges that you are experiencing regarding the Medicaid Credit Balance Reporting (MSBR) submissions. Provider Portal enhancements and related MCBR policies are in development to make MCBR submissions seamless in the future. DMAP encourages providers at this time to review each qualifying quarter and adjust claims accordingly as they are unable to accept checks. Adjustments should be processed through the Provider Portal, and DMAP will continue to provide additional communications.
